As a sampling of programs offered by United Arts Appeal member organizations, the Chautauqua Regional Youth Ballet (*CRYB.net*) has classes in creative dance, modern dance, and

all levels of ballet, from pre-ballet to pre-professional, including a class just for boys. Their Spring Gala Performance is set for Friday, June 17, in the Chautauqua Institution Amphitheater.

Community Music Project's (*CommunityMusicProject.com*) CMP Chorale begins rehearsals this month for their concert on Sunday, May 15. There are still openings for new students and their parents for Semester 2 of the Children's Music Studio.

Over the next few months, the Fredonia Opera House Performing Arts Center (*FredOpera.org*). will feature current independent films, live concerts including the three-concert Bach & Beyond Baroque Music Festival (June 10-12) and Grammy Award winners Tom Paxton & The DonJuans (June 18), the Metropolitan Opera Live at the Met in HD, Art & Architectures On Screen, and Stage On Screen via satellite that includes ballet from Moscow and theatre from London.

In addition to Facebook Live student performance events on March 31, April 28, May 26 and June 19, Infinity Visual and Performing Arts (*InfinityPerformingArts.org*) has youth and adult private and group lessons in various fields of music, art, dance, theater, and literature.

Jamestown's Lucille Ball Little Theatre is presenting John Cariani's *Almost, Maine* on Fridays and Saturdays, March 4, 5, 11, and 12, at 7:30 p.m. and Sundays, March 6 and 13, at 2 p.m. (*LucilleBallLittleTheatre.org*). As a *New York Times* review noted, "This is a beautifully structured play, with nifty surprise endings...."

The Western New York Chamber Orchestra (<u>WNYChamberOrchestra.com</u>) travels to Erie, Pa., to perform Gabriel Faure's *Requiem* on Saturday, April 23, 7 p.m., at the Episcopal Cathedral of St. Paul. On Sunday, April 24, 4 p.m., in the King Concert Hall in SUNY Fredonia's Rockefeller Arts Center, they perform the Durufle *Requiem* and Faure *Requiem* with the Masterwork Choir of SUNY Fredonia and soloists.
